**AMENDMENT ONE BETWEEN

STANDARD AMENDMENT**

THIS AMENDMENT, entered into between the Area Agency on Aging of Central Florida, Inc., d/b/a Senior Resource Alliance, hereinafter referred to as the "Agency" and Brevard Alzheimer's Foundation, Inc., hereinafter referred to as the "Contractor," and collectively referred to as the "Parties," amends contract **BAFI-ADI-20-21**.

All provisions not in conflict with this Amendment are still in effect and are to be performed at the level specified in the contract.


This Amendment and all its attachments are hereby made part of the contract.
