

It also includes any wet mops, dust mops, vacuums, microfiber cloths, sponges, dust cloths, gloves, or anything used in the cleaning process.

Sconyers Family Janitorial Services JANITORIAL SPECIFICATIONS

Note: At the request of Joe's Club Melbourne, Sconyers family Janitorial to the building, a left side and a right side. The left side will be cleaned only once per week. The right side three times per week. Any mention of "Daily" refers to each scheduled visit.

Main Entrance, Lobbies and Corridors:

Sweep and/or vacuum full floor area. Spot clean floors and carpet. Walk off mats are to be vacuumed.

Vacuum any entryway floor mats. Daily

Clean doorknobs, push bars, kick plates, railings, seats and other surfaces.

Dust mop all hard and resilient floors. Daily

Report items in need of repair, e.g., inoperative lights, broken windows and doors, leaking sinks, urinals, commodes, broken fixtures, etc.

Empty, clean and disinfect all receptacles used for the collection of solid waste. Replace liners as necessary.

Sweep and wet mop or scrub floor with a neutral pH cleaner. Daily

Clean, sanitize and polish all surfaces of fixtures, including toilets, urinals, wash basins, commodes, etc. Daily

Spot clean doors/entry ways, to remove dirt, dust and stains.

Vacuum offices that have left the doors open.

Empty trash cans and replace liners. Daily

Offices and conference rooms:

Empty waste baskets and remove trash to designated disposal area. Replace plastic liners as necessary.

Dust all horizontal surfaces to remove dust. Computers, printers, monitors, and working papers shall not be moved or disturbed.

Kitchenette/Break Rooms:

Wipe down counter tops, exterior of appliances, vending machines, tabletops, etc. and remove trash and replace any liners. Vacuum the floor and mop.

Report fires, hazardous conditions, and items in need of repair, e.g., inoperative lights, broken windows and doors, torn carpets, leaking sinks, urinals, commodes, etc., to the property manager.

Sconyersfj will not enter rooms or areas not designated by Owner.

JANITORIAL SERVICES AGREEMENT

This JANITORIAL SERVICES AGREEMENT is made and entered into this 25th day of August, 2021, by and between Joe's Club and SCONYERS FAMILY JANITORIAL SERVICES.

WITNESSETH:

CONTROL OF THE PROPERTY OF THE

WHEREAS Joe's Club is the owner or tenant of the commercial office building situated at 4676 N. Wickham Rd. Melbourne, FL 32935.

WHEREAS Joe's Club desires to enter into this Agreement for the purposes of hiring and retaining Sconyers Family Janitorial Service to provide cleaning and janitorial services and Sconyers Family Janitorial Service accept such employment in accordance with the terms and provisions contained herein.

NOW, THEREFORE, in consideration of the premises and the mutual promises of the parties herein contained, Joe's Club and Sconyers Family Janitorial Service hereby covenant and agree as follows:

- I.- CONTRACT WITH Sconyers Family Janitorial Joe's Club hereby contracts Sconyers Family Janitorial, and Sconyers Family Janitorial hereby accepts such contract, to provide and furnish within the common areas of the building (hallways, lobby, restrooms, offices, etc.) those cleaning and janitorial services more specifically described in the preceding janitorial specifications. Such cleaning and janitorial services shall be provided and furnished after normal business hours, five times per week. During the term of this Agreement, except on holidays (Memorial Day, Thanksgiving Day, Independence Day, Labor Day, Christmas Eve, Christmas Day, and New Year's Eve and New Year's Day.) All such services shall be performed in a good and workmanlike manner.
- 2.- <u>TERM</u> Except as otherwise provided herein, this Agreement shall remain in effect for a period of six months commencing on September 1, 2021 and expiring on March 1, 2022.
- 3.- <u>COMPENSATION</u> As full compensation for Sconyers Family Janitorial's performance of the services to be furnished under this Agreement, Joe's Club shall pay Sconyers Family Janitorial the monthly rate of \$2,000.00

If Joe's Club wishes to retain Sconyers Family Janitorial for any special events or activities beyond the scheduled weekly visit (e.g., post-party cleanup, requested weekend work, working on a holiday listed above, etc.), or cleaning on a holiday listed in Section 1, then Joe's Club shall pay \$30.00/hour per person with a minimum commitment of two hours to assist in any potential extra pay.

Payments are due five days after Joe's Club's receipt of invoice. Sconyers Family Janitorial shall invoice on the first of the month for the services provided in the current month. Sconyers Family Janitorial accepts checks, Cash, and Cash app.

4.- <u>CONTRACT STATUS</u> Sconyers Family Janitorial's status under this Agreement shall be that of an independent contractor, and not that of an agent of Owner. Sconyers Family Janitorial has no authority to enter into any contracts or agreements on behalf of Owner. Sconyers Family Janitorial

warrants the compliance with all federal, state and local laws regarding employment, business permits and licenses that may be required for it to perform the services set forth in this Agreement.

- 5.- INSURANCE At all times, during the term of this Agreement, Sconyers Family Janitorial shall purchase from and maintain in a company or companies reasonably acceptable to Joe's Club. Feel free to request a certificate of insurance at any time.
- 6.- <u>TERMINATION</u> If Sconyers Family Janitorial shall default in the performance of its obligations hereunder, Joe's Club may send a written notice to Sconyers Family Janitorial describing reasonably the default. If Sconyers Family Janitorial within a reasonable period (not to exceed five (5) days) does not commence reasonable steps to cure the default, or if having timely commenced, fails to carry the same to reasonable and timely completion, Joe's Club may forthwith terminate this Agreement. Furthermore, this Agreement may be terminated at any time if the building is sold by Joe's Club. *This Agreement may also terminate, at any time or any reason, with a thirty (30) day advance written notice indicating such intent by Sconyers Family Janitorial.*
 - 7.- NOTICE Any written notice pursuant to the terms hereof shall be provided to:

- 8.- <u>SUPPLIES</u> All supplies provided by Joe's Club stored at this location and equipment used to complete this assignment are property of Joe's Club and may not be taken, removed, borrowed, altered or otherwise disposed of by Sconyers Family Janitorial. Upon termination of this contract or non-renewal, then all equipment and supplies provided by Joe's Club shall remain on the premises. Unless a written agreement is made beforehand, Sconyers Family Janitorial does not provide dispensers (for soap, paper, etc), air fresheners, floor mats, drinking water supplies, toilet paper dispensers, trash cans, sanitary dispensers, walk-off mats, recycling bins, hand sanitizers and refills, ash trays, or other items not ordinary in the cleaning process.
- 9.- MORALITY AND ETHICS Joe's Club or representative of owner may never engage in any illegal, immoral, or unethical activity that entraps, uses, or solicits Sconyers Family Janitorial or representative of Sconyers Family Janitorial. Activities include bribes, asking Sconyers Family Janitorial to lie on their behalf, falsifying records, or any other activity that is illegal or any activity Sconyers Family Janitorial deems as immoral or unethical. Sconyers Family Janitorial reserves the right to report this wrongdoing to any representative of Joe's Club or any authority.
- Janitorial goal is to protect our clients, their employees, and guests. We cannot guarantee that your location will be disease-free. While our cleaning process could include antivirals and disinfectants, not every product we use is an antiviral or disinfectant due to the nature of the item being cleaned. Moreover, viral transmissions like COVID-19 include airborne. There is no cleaning that can stop cough or sneeze

droplets from transmitting person to person. It's also impossible or unreasonable to disinfect every surface after one single person touches it.

- 11.- <u>STAFFING</u> Sconyers Family Janitorial understands the need for security. Sconyers Family Janitorial shall not bring any person on the premises of the Building without Joe's Club approval first.
- 12.- COMPLETE AGREEMENT This Agreement, together with the preceding building janitorial specifications and insurance certificates, forms the complete Agreement between Sconyers Family Janitorial and Joe's Club for all cleaning and janitorial services to be furnished within the building, and may not be modified except by an instrument in writing signed by both Joe's Club and Sconyers Family Janitorial.
