AREA AGENCY ON AGING OF CENTRAL FLORIDA, INC. STANDARD CONTRACT

RESPITE FOR ELDERS LIVING IN EVERYDAY FAMILIES (RELIEF)

THIS CONTRACT is entered into between the Area Agency on Aging of Central Florida Inc., d/b/a Senior Resource Alliance (Agency) and Brevard Alzheimer Foundation, Inc. (Contractor), collectively referred to as the "Parties." The term Contractor for this purpose may designate a Vendor, Subgrantee, or **Subrecipient.**

WITNESSETH THAT

WHEREAS, the Agency has determined that it is in need of certain services as described herein; and

WHEREAS, the Contractor has demonstrated that it has the requisite expertise and ability to faithfully perform such services as an independent Contractor of the Agency.

NOW THEREFORE, in consideration of the services to be performed and payments to be made, together with the mutual covenants and conditions set forth herein, the Parties agree as follows:

1. Purpose of Contract:

The purpose of this contract is to provide services in accordance with the terms and conditions specified in this contract including all attachments, forms, and exhibits which constitute the contract document.

2. Incorporation of Documents within the Contract:

The contract will incorporate attachments, proposal(s), state plan(s), grant agreements, relevant Agency handbooks, manuals and/or desk books, and BAFI-Master Contract-17, as an integral part of the contract, except to the extent that the contract explicitly provides to the contrary. In the event of conflict in language among any of the documents referenced above, the specific provisions and requirements of the contract document(s) shall prevail over inconsistent provisions in the proposal(s) or other general materials not specific to this contract document and identified attachments.

3. Term of Contract:

This contract shall begin at twelve (12:00) A.M., Eastern Standard Time **July 1, 2020** or on the date the contract has been signed by the last party required to sign it, whichever is later. It shall end at eleven fiftynine (11:59) P.M., Eastern Standard Time **June 30, 2021**.

4. Contract Amount:

The Agency agrees to pay for contracted services according to the terms and conditions of this contract in an amount not to exceed \$117,000.00; subject to the availability of funds. Any costs or services paid for under any other contract or from any other source are not eligible for payment under this contract.

5. Renewals:

By mutual agreement of the Parties, in accordance with Section 287.058(1) (g), Florida Statutes (F.S.), the Agency may renew the contract for a period not to exceed three years, or the term of the original contract, whichever is longer. The renewal price, or method for determining a renewal price, is set forth in the bid, proposal, or reply. No other costs for the renewal may be charged. Any renewal is subject to the same terms and conditions as the original contract and contingent upon satisfactory performance evaluations by the Agency and the availability of funds.

6. Compliance with Federal Law:

- **6.1** If this contract contains federal funds this section shall apply.
 - **6.1.1** The Contractor shall comply with the provisions of 45 Code of Federal Regulations (CFR) 75 and/or 45 CFR Part 92, 2 CFR Part 200, and other applicable regulations.

- **6.1.2** If this contract contains federal funds and is over \$100,000.00, the Contractor shall comply with all applicable standards, orders, or regulations issued under Section 306 of the Clean Air Act as amended (42 United States Code (U.S.C.) § 7401, et seq.), Section 508 of the Federal Water Pollution Control Act as amended (33 U.S.C. § 1251, et seq.), Executive Order 11738, as amended, and, where applicable, Environmental Protection Agency regulations 2 CFR Part 1500. The Contractor shall report any violations of the above to the Agency.
- **6.1.3** Neither the Contractor nor any agent acting on behalf of the Contractor may use any federal funds received in connection with this contract to influence legislation or appropriations pending before Congress or any state legislature. The Contractor must complete all disclosure forms as required, specifically the Certification and Assurances Attachment, which must be completed and returned to the Contract Manager prior to the execution of this contract.
- **6.1.4** In accordance with Appendix II to 2 CFR Part 200, the Contractor shall comply with Executive Order 11246, Equal Employment Opportunity, as amended by Executive Order 11375 and others, and as supplemented in Agency of Labor regulations 41 CFR Part 60 and in Agency of Health and Human Services regulations 45 CFR Part 92, if applicable.
- 6.1.5 A contract award with an amount expected to equal or exceed \$25,000.00 and certain other contract awards will not be made to parties listed on the government-wide Excluded Parties List System, in accordance with the Office of Management and Budget (OMB) guidelines at 2 CFR Part 180 that implement Executive Orders 12549 and 12689, "Debarment and Suspension." The Excluded Parties List System contains the names of parties debarred, suspended, or otherwise excluded by agencies, as well as parties declared ineligible under statutory or regulatory authority other than Executive Order 12549. The Contractor shall comply with these provisions before doing business or entering into subcontracts receiving federal funds pursuant to this contract. The Contractor shall complete and sign the Certifications and Assurances Attachment prior to the execution of this contract.
- 6.2 The Contractor shall not employ an unauthorized alien. The Agency will consider the employment of unauthorized aliens a violation of the Immigration and Nationality Act (8 U.S.C. § 1324a) and the Immigration Reform and Control Act of 1986 (8 U.S.C. § 1101). Such violation will be cause for unilateral cancellation of this contract by the Agency.
- 6.3 If the Contractor is a non-profit provider and is subject to Internal Revenue Service (IRS) tax exempt organization reporting requirements (filing a Form 990 or Form 990-N), and has its tax exempt status revoked for failing to comply with the filing requirements of the Pension Protection Act of 2006 or for any other reason, the Contractor must notify the Agency in writing within thirty (30) days of receiving the IRS notice of revocation.
- 6.4 The Contractor shall comply with Title 2 CFR Part 175 regarding Trafficking in Persons.
- 6.5 Unless exempt under 2 CFR § 170.110(b), the Contractor shall comply with the reporting requirements of the Transparency Act as expressed in 2 CFR Part 170.
- 6.6 To comply with Presidential Executive Order 12989, as amended, and State of Florida Executive Order Number 11-116, Contractor agrees to utilize the U.S. Agency of Homeland Security's E-verify system to verify the employment of all new employees hired by Contractor during the contract term. Contractor shall include in related subcontracts a requirement that Subcontractors performing work or providing services pursuant to the state contract utilize the E-verify system to verify employment of all new employees hired by the Subcontractor during the contract term. Contractors meeting the terms and conditions of the E-Verify System are deemed to be in compliance with this provision.

7. Compliance with State Law:

7.1 This contract is executed and entered into in the State of Florida, and shall be construed, performed, and

- enforced in all respects in accordance with Florida law, including Florida provisions for conflict of laws.
- 7.2 If this contract contains state financial assistance funds, the Contractor shall comply with Section 215.97, F.S., and Section 215.971, F.S., and expenditures must be in compliance with laws, rules, and regulations including, but not limited to, the Reference Guide for State Expenditures.
- 7.3 The Contractor shall comply with the requirements of Section 287.058, F.S., as amended.
 - **7.3.1** The Contractor shall perform all tasks contained in Attachment I.
 - **7.3.2** The Contractor shall provide units of deliverables, including reports, findings, and drafts, as specified in Attachment I, to be received and accepted by the AGENCY Contract Manager prior to payment.
 - **7.3.3** The Contractor shall comply with the criteria and final date by which such criteria must be met for completion of this contract as specified in Attachment I, Section III. Method of Payment.
 - **7.3.4** The Contractor shall submit bills for fees or other compensation for services or expenses in sufficient detail for a proper pre-audit and post-audit.
 - **7.3.5** If itemized payment for travel expenses is permitted in this contract, the Contractor shall submit invoices for any travel expenses in accordance with Section 112.061, F.S., or at such lower rates as may be provided in this contract.
 - **7.3.6** The Contractor shall allow public access to all documents, papers, letters, or other public records as defined in Section 119.011(12), F.S., made or received by the Contractor in conjunction with this contract except for those records which are made confidential or exempt by law. The Contractor's refusal to comply with this provision will constitute an immediate breach of contract for which the Agency may unilaterally terminate this contract.
- **7.4** If clients are to be transported under this contract, the Contractor shall comply with the provisions of Chapter 427, F.S., and Rule Chapter 41-2, Florida Administrative Code (F.A.C).
- 7.5 Subcontractors who are on the Discriminatory Vendor List may not transact business with any public entity, in accordance with the provisions of Section 287.134, F.S.
- **7.6** The Contractor shall comply with the provisions of Section 11.062, F.S., and Section 216.347, F.S., which prohibit the expenditure of contract funds for the purpose of lobbying the legislature, judicial branch or a state agency.
- 7.7 The Agency may, at its option, terminate the Contract if the Contractor is found to have submitted a false certification as provided under Section 287.135(5), F.S., has been placed on the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, the Scrutinized Companies with Activities in Sudan List, or the Scrutinized Companies that Boycott Israel List, or if the Contractor has been engaged in business operations in Cuba or Syria or is engaged in a boycott of Israel.

8. Background Screening:

The Contractor shall ensure that the requirements of Section 430.0402 and Chapter 435, F.S., as amended, are met regarding background screening for all persons who meet the definition of a direct service provider and who are not exempt from the Agency's level 2 background screening pursuant to Sections 430.0402(2)-(3), F.S. The Contractor must also comply with any applicable rules promulgated by the Agency and the Agency for Health Care Administration regarding implementation of Section 430.0402 and Chapter 435, F.S. To demonstrate compliance with this provision, Contractor shall submit the Background Screening Affidavit of Compliance (Screening Form) to the Agency within thirty (30) days of execution of this contract. Should the Agency have a completed Screening Form on file for the Contractor, a new Screening Form will be required every twelve (12) months.

9. Grievance Procedures:

The Contractor shall develop, implement, and ensure that its Subcontractors have established grievance procedures to process and resolve client dissatisfaction with, or denial of, service(s) and to address complaints regarding the termination, suspension or reduction of services, as required for receipt of funds. These procedures, at a minimum, will provide for notice of the grievance procedure and an opportunity for review of the Subcontractor's determination(s).

10. Public Records and Retention:

- **10.1** By execution of this contract, Contractor agrees to all provisions of Chapter 119, F.S., and any other applicable law, and shall:
 - **10.1.1** Keep and maintain public records required by the Agency to perform the contracted services.
 - **10.1.2** Upon request from the Agency's custodian of public records, provide the Agency a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Chapter 119, F.S., or as otherwise provided by law.
 - **10.1.3** Ensure that public records that are exempt, or confidential and exempt, from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the Contractor does not transfer the records to the Agency.
 - 10.1.4 Upon completion of the contract, the Contractor will either transfer, at no cost to the Agency, all public records in possession of the Contractor to the Agency or will keep and maintain public records required by the Agency. If the Contractor transfers all public records to the Agency upon completion of the contract, Contractor shall destroy any duplicate public records that are exempt, or confidential and exempt, from public records disclosure requirements. If the Contractor keeps and maintains public records upon completion of the contract, the Contractor shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the Agency in a format that is compatible with the information technology systems of the Agency.
- 10.2 The Agency may unilaterally cancel this contract, notwithstanding any other provisions of this contract, for refusal by the Contractor to comply with Section 10 of this contract by not allowing public access to all documents, papers, letters, or other material made or received by the Contractor in conjunction with this contract, unless the records are exempt, or confidential and exempt, from Section 24(a) of Article I of the State Constitution and Section 119.07(1), F.S.

10.3 Upon termination of this contract, whether for convenience or for cause as detailed in section 53 of this

contract, the Contractor and Subcontractors shall, at no cost to the Agency, transfer all public records in their possession to the Agency and destroy any duplicate public records that are exempt, or confidential and exempt, from public records disclosure requirements. All records stored electronically shall be provided to the Agency in a format that is compatible with the information technology systems of the Agency.

11. Audits. Inspections. Investigations:

- 11.1 The Contractor shall establish and maintain books, records, and documents (including electronic storage media) sufficient to reflect all assets, obligations, unobligated balances, income, interest, and expenditures of funds provided by the Agency under this contract. Contractor shall adequately safeguard all such assets and ensure that they are used solely for the purposes authorized under this contract. Whenever appropriate, financial information should be related to performance and unit cost data.
- 11.2 The Contractor shall retain and maintain all client records, financial records, supporting documents, statistical records, and any other documents (including electronic storage media) pertinent to this contract for a period of six (6) years after completion of the contract, or longer when required by law. In the event an audit is required by this contract, records shall be retained for a minimum period of six (6) years after the audit report is issued or until resolution of any audit findings or litigation based on the terms of this contract, at no additional cost to the Agency.
- 11.3 Upon demand, at no additional cost to the Agency, the Contractor shall facilitate the duplication and transfer of any records or documents during the required retention period.
- 11.4 The Contractor shall ensure that the records described in this section will be subject at all reasonable times to inspection, review, copying, or audit by federal, state, or other personnel duly authorized by the Agency.
- 11.5 At all reasonable times for as long as records are maintained, persons duly authorized by the Agency and federal auditors, pursuant to 45 CFR Part 75, shall be allowed full access to and the right to examine any of the Contractor's contracts and related records and documents pertinent to this specific contract, regardless of the form in which kept.
- 11.6 The Contractor shall provide a Financial and Compliance Audit to the Agency as specified in this contract and ensure that all related third-party transactions are disclosed to the auditor.
- 11.7 Contractor agrees to comply with the Inspector General in any investigation, audit, inspection, review, or hearing performed pursuant to Section 20.055, F.S. Contractor further agrees that it shall include in related subcontracts a requirement that subcontractors performing work or providing services pursuant to this contract agree to cooperate with the Inspector General in any investigation, audit, inspection, review, or hearing pursuant to Section 20.055(5), F.S. By execution of this contract the Contractor understands and will comply with this subsection.

12. Nondiscrimination-Civil Rights Compliance:

- 12.1 The Contractor shall execute Assurances as stated in the Assurances-Non-Construction Programs Attachment that it will not discriminate against any person in the provision of services or benefits under this contract or in employment because of age, race, religion, color, disability, national origin, marital status, or sex in compliance with state and federal law and regulations. The Contractor further assures that all Contractors, Subcontractors, Sub-grantees, or others with whom it arranges to provide services or benefits in connection with any of its programs and activities are not discriminating against clients or employees because of age, race, religion, color, disability, national origin, marital status, or sex.
- **12.2** During the term of this contract, the Contractor shall complete and retain on file a timely, complete, and accurate Civil Rights Compliance Checklist, attached to this contract.

- 12.3 The Contractor shall establish procedures pursuant to federal law to handle complaints of discrimination involving services or benefits through this contract. These procedures shall include notifying clients, employees, and participants of the right to file a complaint with the appropriate federal or state entity.
- 12.4 If this contract contains federal funds, these assurances are a condition of continued receipt of or benefit from federal financial assistance, and are binding upon the Contractor, its successors, transferees, and assignees for the period during which such assistance is provided. The Contractor further assures that all Subcontractors, Vendors, or others with whom it arranges to provide services or benefits to participants or employees in connection with any of its programs and activities are not discriminating against those participants or employees in violation of the any statutes, regulations, guidelines, and standards. In the event of failure to comply, the Contractor understands that the Agency may, at its discretion, seek a court order requiring compliance with the terms of this assurance or seek other appropriate judicial or administrative relief including, but not limited to, termination of the contract and denial of further assistance.

13. Monitoring by the Agency:

The Contractor shall permit persons duly authorized by the Agency to inspect and copy any records, papers, documents, facilities, goods, and services of the Contractor which are relevant to this contract, and to interview any clients, employees, and Subcontractor employees of the Contractor to assure the Agency of the satisfactory performance of the terms and conditions of this contract. Following such review, the Agency will provide a written report of its findings to the Contractor and, where appropriate, the Contractor shall develop a Corrective Action Plan (CAP). The Contractor hereby agrees to correct all deficiencies identified in the CAP in a timely manner as determined by the Agency's Contract Manager.

14. Provision of Services:

The Contractor shall provide services in the manner described in Attachment I.

15. Coordinated Monitoring with Other Agencies:

If the Contractor receives funding from one or more State of Florida human service agencies, in addition to the Agency, then a joint monitoring visit including such other agencies may be scheduled. For the purposes of this contract, and pursuant to Section 287.0575, F.S., as amended, Florida's human service agencies shall include the Agency, the Agency of Children and Families, the Agency of Health, the Agency for Persons with Disabilities, and the Agency of Veterans' Affairs. Upon notification and the subsequent scheduling of such a visit by the designated agency's lead administrative coordinator, the Contractor shall comply and cooperate with all monitors, inspectors, and/or investigators.

16. Indemnification:

The Contractor shall indemnify, save, defend, and hold harmless the Agency and its agents and employees from any and all claims, demands, actions, and causes of action of whatever nature or character arising out of, or by reason of, the execution of this contract or performance of the services provided for herein. It is understood and agreed that the Contractor is not required to indemnify the Agency for claims, demands, actions, or causes of action arising solely out of the negligence of the Agency.

16.1 Except to the extent permitted by Section 768.28, F.S., or other Florida law, this Section 16 is not applicable to contracts executed between the Agency and state agencies or subdivisions defined in Section 768.28(2), F.S.

17. Insurance and Bonding:

17.1 The Contractor shall provide continuous adequate liability insurance coverage during the existence of this contract and any renewal(s) and extension(s) of it. By execution of this contract, unless it is a state agency or subdivision as defined by Section 768.28(2), F.S., the Contractor accepts full responsibility for identifying and determining the type(s) and extent of liability insurance coverage necessary to

provide reasonable financial protections for the Contractor and the clients to be served under this contract. The limits of coverage under each policy maintained by the Contractor do not limit the Contractor's liability and obligations under this contract. The Contractor shall ensure that the Agency has the most current written verification of insurance coverage throughout the term of this contract. Such coverage may be provided by a self-insurance program established and operating under the laws of the State of Florida. The Agency reserves the right to require additional insurance as specified in this contract.

17.2 Throughout the term of this contract, the Contractor shall maintain an insurance bond from a responsible commercial insurance company covering all officers, directors, employees, and agents of the Contractor authorized to handle funds received or disbursed under all agreements and/or contracts incorporating this contract by reference in an amount commensurate with the funds handled, the degree of risk as determined by the insurance company, and consistent with good business practices.

18. Confidentiality of Information:

The Contractor shall not use or disclose any information concerning a recipient of services under this contract for any purpose prohibited by state or federal law or regulations except with the written consent of a person legally authorized to give that consent or when authorized by law.

19. Health Insurance Portability and Accountability Act:

Where applicable, the Contractor shall comply with the Health Insurance Portability and Accountability Act (42 USC

§ 1320d.), as well as all regulations promulgated thereunder (45 CFR Parts 160, 162, and 164).

20. Incident Reporting:

- 20.1 The Contractor shall notify the Agency immediately but no later than forty-eight (48) hours from the Contractor's awareness or discovery of conditions that may materially affect the Contractor's or Subcontractor's ability to perform the services required to be performed under this contract. Such notice shall be made orally to the Agency's Contract Manager (by telephone) with an email to immediately follow.
- 20.2 The Contractor shall immediately report knowledge or reasonable suspicion of abuse, neglect, or exploitation of a child, aged person, or disabled adult to the Florida Abuse Hotline on the statewide toll-free telephone number (1-800-96ABUSE). As required by Chapters 39 and 415, F.S., this provision is binding upon the Contractor, its Subcontractors, and their employees.

21. Bankruptcy Notification:

During the term of this contract, the Contractor shall immediately notify the Agency if the Contractor, its assignees, Subcontractors, or affiliates file a claim for bankruptcy. Within ten (10) days after notification, the Contractor must also provide the following information to the Agency: (1) the date of filing of the bankruptcy petition; (2) the case number; (3) the court name and the division in which the petition was filed (e.g., Northern District of Florida, Tallahassee Division); and (4) the name, address, and telephone number of the bankruptcy attorney.

22. Sponsorship and Publicity:

- 22.1 As required by Section 286.25, F.S., if the Contractor is a non-governmental organization which sponsors a program financed wholly or in part by state funds, including any funds obtained through this contract, it shall, in publicizing, advertising, or describing the sponsorship of the program, state: "Sponsored by (Contractor's name), Senior Resource Alliance, and the State of Florida, Agency of Elder Affairs." If the sponsorship reference is in written material, the words "State of Florida, Agency of Elder Affairs" shall appear in at least the same size letters or type as the name of the organization.
- 22.2 The Contractor shall not use the words "Senior Resource Alliance, State of Florida, Agency of Elder

Affairs" to indicate sponsorship of a program otherwise financed, unless specific written authorization has been obtained by the Agency prior to such use.

23. Assignments:

- 23.1 The Contractor shall not assign the rights and responsibilities under this contract without the prior written approval of the Agency. Any sublicense, assignment, or transfer otherwise occurring without prior written approval of the Agency shall constitute a material breach of the contract. In the event the State of Florida approves assignment of the Contractor's obligations, the Contractor remains responsible for all work performed and all expenses incurred in connection with this contract.
- 23.2 The Senior Resource Alliance is, at all times, entitled to assign or transfer, in whole or part, its rights, duties, or obligations under this contract to another Contractor in the State of Florida upon giving prior written notice to the Contractor.
- 23.3 This contract shall remain binding upon the successors in interest of the Contractor and the Agency.

24. Subcontracts:

The Contractor is responsible for all work performed and for all commodities produced pursuant to this contract, whether actually furnished by the Contractor or its Subcontractors. Any subcontracts shall be evidenced by a written document and subject to any conditions of approval the Agency deems necessary. The Contractor further agrees that the Agency will not be liable to the Subcontractor in any way or for any reason. The Contractor, at its expense, shall defend the Agency against any such claims.

25. Independent Capacity of Contractor:

It is the intent and understanding of the Parties that the Contractor and any of its Subcontractors are independent Contractors and are not employees of the Agency, and that they shall not hold themselves out as employees or agents of the Agency without prior specific authorization from the Agency. It is the further intent and understanding of the Parties that the Agency does not control the employment practices of the Contractor and will not be liable for any wage and hour, employment discrimination, or other labor and employment claims against the Contractor or its Subcontractors. All deductions for social security, withholding taxes, income taxes, contributions to unemployment compensation funds, and all necessary insurance for the Contractor are the sole responsibility of the Contractor.

26. Payment:

Payments shall be made to the Contractor for all completed and approved deliverables (units of service) as defined in Attachment I. The Agency Contract Manager will have final approval of the Contractor's invoice submitted for payment and will approve the invoice for payment only if the Contractor has met all terms and conditions of the contract, unless the bid specifications, purchase order, or this contract specify otherwise. The approved invoice will be submitted to the Agency's finance section for budgetary approval and processing. Disputes arising over invoicing and payments will be resolved in accordance with the provisions of Section 215.422, F.S. A Vendor Ombudsman has been established within the Florida Agency of Financial Services and may be contacted at 800-342-2762.

27. Return of Funds:

The Contractor shall return to the Agency any overpayments due to unearned funds or funds disallowed, and any interest attributable to such funds pursuant to the terms and conditions of this contract, that were disbursed to the Contractor by the Agency. In the event that the Contractor or its independent auditor discovers that an overpayment has been made, the Contractor shall repay said overpayment immediately without prior notification from the Agency. In the event that the Agency first discovers an overpayment has been made, the Agency Contract Manager will notify the Contractor in writing of such findings. Should repayment not be made forthwith, the Contractor shall be charged at the lawful rate of interest on the outstanding balance pursuant to Section 55.03, F.S., after Agency notification or Contractor discovery.

28. Data Integrity and Safeguarding Information:

The Contractor shall ensure an appropriate level of data security for the information the Contractor is collecting or using in the performance of this contract. An appropriate level of security includes approving and tracking all Contractor employees that request system or information access and ensuring that user access has been removed from all terminated employees. The Contractor, among other requirements, must anticipate and prepare for the loss of information processing capabilities. All data and software shall be routinely backed up to ensure recovery from losses or outages of the computer system. The security over the backed-up data is to be as stringent as the protection required of the primary systems. The Contractor shall ensure all Subcontractors maintain written procedures for computer system backup and recovery. The Contractor shall complete and sign the Certification Regarding Data Integrity Compliance for Agreements, Grants, Loans, and Cooperative Agreements prior to the execution of this contract.

29. Computer Use and Social Media Policy:

The Agency has implemented a Social Media Policy, in addition to its Computer Use Policy, which applies to all employees, contracted employees, consultants, Other Personal Services (OPS) employees and volunteers, including all personnel affiliated with third parties, such as, but not limited to, contractors and subcontractors. Any entity that uses the Agency's computer resource systems must comply with the Agency's policy regarding social media. Social Media includes, but is not limited to, blogs, podcasts, discussion forums, Wikis, RSS feeds, video sharing, social networks like MySpace, Facebook and Twitter, as well as content sharing networks such as flickr and YouTube. This policy is available on the Agency's website at: http://elderaffairs.state.fl.us/Agency/financial.php.

30. Conflict of Interest:

The Contractor shall establish safeguards to prohibit employees, board members, management, and Subcontractors from using their positions for a purpose that constitutes or presents the appearance of personal or organizational conflict of interest or personal gain. No employee, officer, or agent of the Contractor or Subcontractor shall participate in the selection or in the award of a contract supported by state or federal funds if a conflict of interest, real or apparent, would be involved. Such a conflict would arise when: (a) the employee, officer or agent; (b) any member of his/her immediate family; (c) his or her partner; or (d) an organization which employs, or is about to employ, any of the above individuals, has a financial or other interest in the firm being selected for award. The Contractor's or Subcontractor's officers, employees, or agents will neither solicit nor accept gratuities, favors, or anything of monetary value from Contractors, potential Contractors, or parties to Subcontracts. The Contractor's board members and management must disclose to the Agency any relationship which may be, or may be perceived to be, a conflict of interest within thirty (30) calendar days of an individual's original appointment or placement in that position, or, if the individual is serving as an incumbent, within thirty (30) calendar days of the commencement of this contract. The Contractor's employees and Subcontractors must make the same disclosures described above to the Contractor's board of directors. Compliance with this provision will be monitored.

31. Patents, Copyrights, Royalties:

If this contract is awarded state funding and if any discovery, invention, or copyrightable material is developed or produced in the course of or as a result of work or services performed under this contract or in any way connected with this contract, or if ownership of any discovery, invention, or copyrightable material was purchased in the course of or as a result of work or services performed under this contract, the Contractor shall refer the discovery, invention, or copyrightable material to the Department to be referred to the Department of State. Any and all patent rights or copyrights accruing under this contract are hereby reserved to the State of Florida in accordance with Chapter 286,

- F.S. Pursuant to Section 287.0571(5) (k), F.S., the only exceptions to this provision shall be those that are clearly expressed and reasonably valued in this contract.
- 34.1 If the primary purpose of this contract is the creation of intellectual property, the State of Florida shall

- retain an unencumbered right to use such property, notwithstanding any agreement made pursuant to this Section 34.
- 34.2 If this contract is awarded solely federal funding, the terms and conditions are governed by 2 CFR § 200.315 or 45 CFR § 75.322, as applicable.
- 34.3 Notwithstanding the foregoing provisions, if the Contractor or one of its Subcontractors is a university and a member of the State University System of Florida, then Section 1004.23, F.S., shall apply, but the Agency shall retain a perpetual, fully-paid, nonexclusive license for its use and the use of its Contractors, Subcontractors, or Assignees of any resulting patented, copyrighted, or trademarked work products.

32. Emergency Preparedness and Continuity of Operations:

- 32.1 If the tasks to be performed pursuant to this contract include the physical care and control of clients, or the administration and coordination of services necessary for client health, safety, or welfare, the Contractor shall, within thirty (30) calendar days of the execution of this contract, submit to the AGENCY Contract Manager, verification of an Emergency Preparedness Plan. In the event of an emergency, the Contractor shall notify the Agency of emergency provisions.
- 32.2 In the event a situation results in a cessation of services by a Subcontractor, the Contractor shall remain responsible for performance under this contract and must follow procedures to ensure continuity of operations without interruption.

33. Equipment:

- 33.1 Equipment means: (a) tangible personal property (including information technology systems) having a useful life of more than one year and a per-unit acquisition cost which equals or exceeds the lesser of the capitalization level established by the organization for the financial statement purposes, or \$5,000.00 [for federal funds 2 CFR §
 - 200.33 and 45 CFR § 75.2, as applicable], or (b); nonexpendable, tangible personal property of a non-consumable nature with an acquisition cost of \$1,000.00 or more per unit, and expected useful life of at least one (1) year; and hardback bound books not circulated to students or the general public, with a value or cost of \$250.00 or more [for state funds].
- 33.2 Contractors and Subcontractors who are Institutions of Higher Education, Hospitals, and Other Non-Profit Organizations shall have written property management standards in compliance with 2 CFR Part 200 Administrative Requirements (formerly OMB Circular A-110) that include: (a) a property list with all the elements identified in the circular; (b) a procedure for conducting a physical inventory of equipment at least once every two (2) years; (c) a control system to insure adequate safeguards to prevent loss, damage, or theft of the equipment; and (d) maintenance procedures to keep the equipment in good condition. The property records must be maintained on file and shall be provided to the Agency upon request. The Contractor shall promptly investigate, fully document, and notify the Agency Contract Manager of any loss, damage, or theft of equipment. The Contractor shall provide the results of the investigation to the Agency Contract Manager.
- 33.3 The Contractor's property management standards for equipment (including replacement equipment), whether acquired in whole or in part with federal funds and federally-owned equipment shall, at a minimum, meet the following requirements and shall include accurately maintained equipment records with the following information:
 - **33.3.1** Property records must be maintained that include a description of the equipment;
 - **33.3.2** Manufacturer's serial number, model number, federal stock number, national stock number, or other identification number;
 - 33.3.3 Source of funding for the equipment, including the federal award identification number;
 - **33.3.4** Whether title vests in the Contractor or the federal government;

- 33.3.5 Acquisition date (or date received, if the equipment was furnished by the federal government);
- **33.3.6** Information from which one can calculate the percentage of federal participation in the cost of the equipment (not applicable to equipment furnished by the federal government);
- 33.3.7 Location, use and condition of the equipment and the date the information was reported;
- 33.3.8 Unit acquisition cost; and
- **33.3.9** Ultimate disposition data, including date of disposal and sales price or the method used to determine current fair market value where a Contractor compensates the federal awarding agency for its share.
- **33.3.10** A physical inventory must be taken, and the results reconciled with the property records at least once every two (2) years.
- **33.3.11** A control system must be developed to ensure adequate safeguards to prevent loss, damage, or theft of the property. Any loss, damage, or theft must be investigated. 45 CFR § 75.320(d) (3).
- **33.3.12** Adequate maintenance procedures must be developed to keep the property in good condition.
- **33.3.13** If the Contractor is authorized or required to sell the equipment, proper sales procedures must be established to ensure the highest possible return.
- 33.4 Equipment purchased with federal funds with an acquisition cost over \$5,000.00 and equipment purchased with state funds with an acquisition cost over \$1,000.00 is part of the cost of carrying out the activities and functions of the grant awards and title (ownership) will vest in the Contractor [for federal funds see 2 CFR § 200.313(a) and 45 CFR § 75.320(a), as applicable], subject to the conditions of 2 CFR Part 200 and/or 45 CFR Part 75. Equipment purchased under these thresholds is considered supplies and is not subject to property standards. Equipment purchased with funds identified in the budget attachments to agreements covered by this contract or identified in the sub-agreements with Subcontractors (not included in a cost methodology), is subject to the conditions of Chapter 273, F.S., rule 60A-1.017, F. A. C., and 2 CFR Part 200 and/or 45 CFR Part 75.
- 33.5 The Contractor shall not dispose of any equipment or materials provided by the Agency or purchased with funds provided through this contract without first obtaining the approval of the AGENCY Contract Manager. When disposing of property or equipment the Contractor must submit a written request for disposition instructions to the Agency's Contract Manager. The request should include a brief description of the property, purchase price, funding source, and percentage of state or federal participation, acquisition date and condition of the property. The request should also indicate the Contractor's proposed disposition of the property (i.e., transfer or donation to another agency that administers federal programs, offer of the items for sale, destroy the items, etc.).
- 33.6 The Agency Contract Manager will issue disposition instructions. If disposition instructions are not received within one hundred twenty (120) days of the written request for disposition, the Contractor is authorized to proceed as directed in 2 CFR § 200.313 or 45 CFR § 75.320, as applicable.
- 33.7 Real property means land (including land improvements), buildings, structures and appurtenances thereto, but excludes movable machinery and equipment. Real property may not be purchased with state or federal funds through agreements covered under this contract without the prior approval of the Agency. Real property purchases from Older Americans Act funds are subject to the provisions of Title 42, Chapter 35, Subchapter III, Part A., and Section 3030b United States Code (U.S.C.). Real property purchases from state funds can only be made through fixed capital outlay grants and aids appropriations and therefore are subject to the provisions of Section 216.348, F.S.
- **33.8** Any permanent storage devices (e.g.: hard drives, removable storage media) must be reformatted and tested prior to disposal to ensure no confidential information remains.
- 33.9 The Contractor must adhere to the Agency's procedures and standards when purchasing Information Technology Resources (ITR) as part of any agreement(s) incorporating this contract by reference. An ITR worksheet is required for any computer related item costing \$1,000.00 or more, including data processing hardware, software, services, supplies, maintenance, training, personnel, and facilities. The

completed ITR worksheet shall be maintained in the LAN administrator's file and must be provided to the Agency upon request. The Contractor has the responsibility to require any Subcontractors to comply with the Agency's ITR procedures.

34. Use of State Funds to Purchase or Improve Real Property:

Any state funds provided for the purchase of or improvements to real property are contingent upon the Contractor or political subdivision granting to the state a security interest in the property at least to the amount of state funds provided for at least five (5) years from the date of purchase or the completion of the improvements or as further required by law.

35. Dispute Resolution:

Any dispute concerning performance of the contract shall be decided by the Agency Contract Manager, who shall reduce the decision to writing and serve a copy on the Contractor.

36. Financial Consequences:

If the Contractor fails to meet the minimum level of service or performance identified in this contract, the Agency shall impose financial consequences as stated in Attachment I.

37. No Waiver of Sovereign Immunity:

Nothing contained in this contract is intended to serve as a waiver of sovereign immunity by any entity to which sovereign immunity may be applicable.

38. <u>Venue:</u>

If any dispute arises out of this contract, the venue of such legal recourse shall be Leon County, Florida.

39. Entire Contract:

This contract contains all the terms and conditions agreed upon by the Parties. No oral agreements or representations shall be valid or binding upon the Agency or the Contractor unless expressly contained herein or by a written amendment to this contract signed by both Parties.

40. Force Majeure:

The Parties will not be liable for any delays or failures in performance due to circumstances beyond their control, provided the party experiencing the force majeure condition provides immediate written notification to the other party and takes all reasonable efforts to cure the condition.

41. Severability Clause:

The Parties agree that if a court of competent jurisdiction deems any term or condition herein void or unenforceable, the other provisions are severable to that void provision and shall remain in full force and effect.

42. Condition Precedent to Contract Appropriations:

The Parties agree that the Agency's performance and obligation to pay under this contract are contingent upon an annual appropriation by the Legislature.

43. Addition/Deletion:

The Parties agree that the Agency reserves the right to add or to delete any of the services required under this contract when deemed to be in the State of Florida's best interest and reduced to a written amendment signed by both Parties. The Parties shall negotiate compensation for any additional services added.

44. Waiver:

The delay or failure by the Agency to exercise or enforce any of its rights under this contract will not constitute or be deemed a waiver of the Agency's right thereafter to enforce those rights, nor will any single or partial exercise of any such right preclude any other or further exercise thereof or the exercise of any other right.

45. Compliance:

The Contractor shall abide by all applicable current federal statutes, laws, rules, and regulations as well as applicable current state statutes, laws, rules and regulations. The Parties agree that failure of the Contractor to abide by these laws shall be deemed an event of default of the Contractor and subject the contract to immediate unilateral cancellation of the contract at the discretion of the Agency.

46. Final Invoice:

The Contractor shall submit the final invoice for payment to the Agency no later than fifteen (15) days after the contract ending date unless otherwise specified in Attachment I. If the Contractor fails to do so, all right to payment is forfeited and the Agency shall not honor any requests submitted after the aforesaid time period. Any payment due under the terms of this contract shall be withheld until all required documentation and reports due from the Contractor and necessary adjustments thereto have been approved by the Agency.

47. Renegotiations of Modifications:

Modifications of the provisions of this contract shall be valid only when they have been reduced to writing and duly signed by both parties. The rate of payment and the total dollar amount may be adjusted retroactively to reflect price level increases and changes in the rate of payment when these have been established through the appropriations process and subsequently identified in the Agency's operating budget.

48. Suspension of Work:

The Agency may, in its sole discretion, suspend any or all activities under the contract or purchase order, at any time, when in the interest of the State to do so. The Agency shall provide the Contractor written notice outlining the particulars of suspension. Examples of the reason for suspension include, but are not limited to, budgetary constraints, declaration of emergency, or other such circumstances. After receiving a suspension notice, the Contractor shall comply with the notice and shall not accept any purchase orders. Within ninety (90) days, or any longer period agreed to by the Contractor, the Agency shall either: (1) issue a notice authorizing resumption of work, at which time activity shall resume, or (2) terminate the contract or purchase order. Suspension of work shall not entitle the Contractor to any additional compensation.

49. Termination:

- **49.1 Termination for Convenience.** The Agency, by written notice to the Contractor, may terminate this contract in whole or in part when the Agency determines in its sole discretion that it is in the State's interest to do so. The Contractor shall not furnish any product after it receives the notice of termination, except as necessary to complete the continued portion of this contract, if any. The Contractor shall not be entitled to recover any cancellation charges or lost profits.
- **49.2 Termination for Cause.** The Agency may terminate this contract if the Contractor fails to: (1) deliver the product within the time specified in the contract or any extension, (2) maintain adequate progress, thus endangering performance of the contract, (3) honor any term of the contract, or (4) abide by any statutory, regulatory, or licensing requirement. Rule 60A-1.006(3), F.A.C., governs the procedure and consequences of default. The Contractor shall continue work on any work not terminated. Except for defaults of Subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from events completely beyond the control, and without the fault or negligence, of the Contractor. If the failure to perform is caused by the default of a Subcontractor at any tier, and if the cause of the default is completely beyond the control of both the Contractor and the Subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted products were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the Parties shall be the same as if the termination had been issued for the convenience of the Agency. The rights and remedies of the Agency in this clause are in addition to any other rights and remedies provided by law or under the contract.

50. Electronic Records and Signature:

The Agency authorizes, but does not require, the Contractor to create and retain electronic records and to use electronic signatures to conduct transactions necessary to carry out the terms of this contract. A Contractor that creates and retains electronic records and uses electronic signatures to conduct transactions shall comply with the requirements contained in the Uniform Electronic Transaction Act, Section 668.50, F.S. All electronic records must be fully auditable; are subject to Florida's Public Records Law, Chapter 119, F.S.; must comply with contract Section 29, Data Integrity and Safeguarding Information; must maintain all

confidentiality, as applicable; and must be retained and maintained by the Contractor to the same extent as non-electronic records are retained and maintained as required by this contract.

- The Agency's authorization pursuant to this section does not authorize electronic transactions between the Contractor and the Agency. The Contractor is authorized to conduct electronic transactions with the Agency only upon further written consent by the Agency.
- 50.2 Upon request by the Agency, the Contractor shall provide the Agency with non-electronic (paper) copies of records. Non-electronic (paper) copies provided to the Agency of any document that was originally in electronic form with an electronic signature must identify the person and the person's capacity who electronically signed the document on any non-electronic copy of the document.

ATTACHMENT I STATEMENT OF WORK

RESPITE FOR ELDERS LIVING IN EVERYDAY FAMILIES (RELIEF)

I. SERVICES TO BE PROVIDED

A. Definitions of Contract Specific Terms

Evening/Weekend Respite: Respite services that begin or end after three o'clock (3:00) P.M.; respite services that end at a time when the majority of adult day care centers in the community have closed; or respite services that are provided at any time on a Saturday or Sunday.

Family Unit. Respite. Stipend. and Volunteer Service System are defined as stated in Section 430.071, Florida Statutes (F.S.).

<u>Local Provider:</u> A local agency that contracts with the Area Agency on Aging (AAA) to deliver RELIEF services to the community.

<u>Unit Cost</u>: The contracted rate of reimbursement to the Contractor for volunteer service hours provided by volunteers, including direct services, travel and training.

<u>Unit of Service</u>: One (1) hour of service provided by a volunteer.

<u>Volunteer Service Hours</u>: The total hours of services provided by volunteers on behalf of the RELIEF program, including direct service, travel, and training hours.

B. General Description

- 1. General Statement. The RELIEF program is a volunteer-based program providing in-home respite to caregivers of frail, homebound elders aged sixty (60) years or older. The RELIEF program provides in-home respite that is beyond the provisions of current public programs using a multigenerational corps of volunteers who provide up to four (4) hours of in-home respite at a time, with an emphasis on evening and weekend hours. The intent of the RELIEF program is to provide family caregivers with a much-needed break to allow the family unit to continue caring for a homebound elder without becoming ill themselves.
- **2. Authority.** The authority for this contract and any subsequent contract amendments made during the contract period is provided by Section 430.071, F.S.
- 3. Scope of Service. The Contractor is responsible for the programmatic, fiscal, and operational management of the RELIEF program. The Contractor shall provide services in a manner consistent with the Contractor's current Area Plan, as updated, and the current Florida Agency of Elder Affairs (AGENCY or Agency) Programs and Services Handbook (AGENCY Handbook), which are hereby incorporated by reference. The Contractor agrees to be bound by all subsequent amendments and revisions to the AGENCY Handbook, and the Contractor agrees to accept all such amendments and revisions via a Notice of Instruction (NOI).

4. Major Program Goals

- **a.** Provide respite services to caregivers of frail, homebound elders age sixty (60) years or older at no cost to the family unit;
- **b.** Develop opportunities for a multigenerational corps of volunteers to contribute to their communities; and
- **c.** Provide stipends and reimbursements to qualified volunteers, enabling them to provide services at no cost to themselves.

C. Clients to be served

- **1. General Description -** RELIEF serves the caregivers of frail, homebound seniors age sixty (60) years or older.
- 2. Client Eligibility In accordance with Section 430.071, F.S., and Rule 58A-1.010(1)(a), Florida Administrative Code (F.A.C.), to receive assistance from the RELIEF program, the family unit must be assessed according to the following guidelines developed by the Agency to determine the need for respite services:
 - **a.** Client must be assessed using the Client Assessment Tool 701A;
 - **b.** The family unit must be unable to pay for respite without jeopardizing other basic needs, including, but not limited to, food, shelter, and medications; and
 - **c.** The homebound elderly individual for whom the family unit is caring is sixty (60) years of age or older, requires assistance to remain in the home, and, without this assistance, would need to move to an assisted living facility or a nursing facility.
- 3. Client Determination The Agency shall have final authority for the determination of client eligibility.
- **4. Contract Limits** In no case shall the Contractor be required to incur costs in excess of the total contract amount to provide services as required by this contract.
- 5. Clients Served This contract does not provide for direct services to clients.

II. MANNER OF SERVICE PROVISION

A. Service Tasks, Performance Measures, Deliverables, and Source Documentation

The Contractor shall subcontract with local providers in the implementation of the RELIEF Program service tasks, deliverables, and performance measures as outlined herein.

1. Assessing Client Needs

The Contractor shall ensure that the requirements of Section 430.071, F.S., are met and shall use the criteria set forth above in Section I.C.2., Client Eligibility, (above), to assess the needs of clients, as well as the Client Assessment Tool 701A as described in the current AGENCY Handbook.

2. Volunteer Recruitment

The Contractor shall ensure the recruitment of volunteers to meet a total annual goal of <u>13,000</u> volunteer service hours during the contract period.

3. Volunteer Qualifications

The Contractor shall ensure that all volunteers providing services under this contract are qualified as set forth below. Volunteer qualifications shall be included in all position descriptions and recruitment advertisements. Qualified volunteers shall:

- **a.** Be age eighteen (18) or older;
- **b.** Pass a Level II criminal background screening in accordance with Section 430.0402, F.S, Chapter 435, F.S, and Section 8 of the Standard Contract; and
- **c.** Commit to serve at least four (4) hours per week.

4. Volunteer Screening

All potential volunteers must undergo a Level II background screening in accordance with Section 430.0402, F.S., and Chapter 435, F.S. All volunteers must pass the Level II background screening before enrolling in the RELIEF program and commencing training and services.

5. Volunteer Orientation

The Contractor shall ensure that all volunteers comply with annual training requirements, including Volunteer Orientation. Each volunteer must complete the orientation program before they provide any services to clients. AGENCY reserves the right to monitor the Contractor's Volunteer Orientation presentation to ensure compliance with this section. Volunteer Orientation shall be documented in the volunteer file. The Contractor's Volunteer Orientation must provide information to volunteers that improves their abilities to serve clients including:

- **a.** A general explanation of the RELIEF program;
- **b.** General information regarding the Contractor, including the Contractor's mission and purpose;
- **c.** The Contractor's policies on personnel, confidentiality, Heath Insurance Portability and Accountability Act of 1996 (HIPAA) privacy policies and procedures, appeal procedures, time sheets, insurance, performance reviews, and other administrative details;
- **d.** An introduction of Contractor staff and volunteers;
- **e.** A description of the objectives of respite services;
- **f.** Information concerning the roles and activities involved in being a RELIEF volunteer;
- **g.** Information about community services available to enable RELIEF volunteers to be better advocates for their clients; and
- h. Information about mandatory reporting of abuse, neglect or exploitation of vulnerable adults

6. Volunteer Training

The Contractor shall ensure that volunteers participate in at least twenty (20) hours of pre-service training before providing any services to clients. After completing pre-service training, volunteers must complete an additional three (3) hours of in-service training each quarter. Volunteers shall be provided information regarding training goals including scheduled meeting dates, in-service training, and volunteer recognition events. The goals of volunteer training are to:

- **a.** Provide detailed instruction on working with elders who have special or exceptional needs;
- **b.** Share information and guidance on matters pertinent to aging; and
- **c.** Provide information about community resources which may be accessed by clients.

7. In-Service Training

The Contractor shall ensure that in-service training is designed to enhance volunteers' knowledge, skills, and abilities in providing program services. While general information topics may be included as part of in-service training, the following subjects shall be included to clarify program objectives and enhance volunteers' skills:

- a. Program policies and procedures;
- **b.** Team building exercises and leadership skill building;
- **c.** Psychological, physiological, and social aspects of aging;
- **d.** Alzheimer's disease and dementia;
- e. Community resources and services;
- **f.** Advocacy;
- g. Household management;
- **h.** Health and personal care assistance; and

i. Abuse, neglect, or exploitation of vulnerable adults

8. Volunteer Training Log

Volunteer training hours shall be documented on the RELIEF Program Volunteer Time and Travel Log (Attachment XIV), which must be approved and signed by the program supervisor in order to receive reimbursement. In addition, volunteer training agendas and sign-in sheets must be submitted with monthly invoices and maintained onsite as part of the volunteer documentation file. All hours of service performed must be recorded on the RELIEF Program Volunteer Time and Travel Log and reported in the RELIEF Monthly Service Record (Attachment XV).

9. Volunteer Stipend Payments

The Contractor may provide volunteers with a stipend for a period of service. Although the stipend is not an hourly wage it may be considered income. The Contractor shall ensure compliance with the Fair Labor Standards Act.

10. Reviews of Volunteer Performance

The Contractor shall ensure each volunteer receives a performance review at least once per calendar year. The Contractor shall inform each volunteer of the timing, content, and process of performance reviews before placement with a client. Performance reviews shall acknowledge any volunteer work that has exceeded expectations, as well as identify any areas that need improvement. The Contractor shall maintain completed performance reviews for all volunteers. At a minimum, performance evaluations shall measure the following for each volunteer:

- a. Performance of tasks/assignments;
- **b.** Reliability and promptness;
- **c.** Relationships with staff, clients, caregivers and other volunteers;
- **d.** Willingness to follow policies and procedures; and
- **e.** Attendance at required meetings/training.

11. Supervision of Volunteers

The Contractor shall ensure volunteers receive proper supervision to maintain a consistently high level of performance and to ensure that the volunteer operates within the guidelines established by the Contractor, the local provider, the Agency, and Section 430.071 F.S. Volunteer position descriptions shall include the name of the staff member(s) authorized to supervise volunteer activities. Supervision activities shall include, but are not limited to, the following:

- **a.** Periodic on-site visits to monitor the volunteer's satisfaction with the assignment and the progress of the client to determine the appropriateness of the assignment;
- **b.** Helping volunteers arrange for community services that benefit the client;
- c. Assisting the volunteer and the clients they serve with maintaining one-on-one relationships; and
- **d.** Conducting orientations (pre-service training) and regular in-service training to explain policies in order to enhance skills related to assignments and provide information on community services.

12. Volunteer Assignments

The Contractor shall ensure volunteers are assigned to clients in a way that benefits both the volunteer and the client. The Contractor may place one volunteer with multiple clients, based upon the demand for services and the ability of the volunteer to provide services. Two (2) volunteers may not serve the same client unless one is a short-term substitute for the other. All RELIEF volunteer assignments must:

a. Involve person-to-person relationships with the clients served;

- **b.** Be meaningful and rewarding to RELIEF volunteers; and
- **c.** Provide meaningful services to the family unit and elder.

13. Volunteer Assignment Priority

The Contractor shall ensure that volunteer assignments shall be made that accomplish the following:

- **a.** Deter or delay institutionalization of homebound elders with mental, emotional, and/or physical impairments who need outside assistance to achieve and maintain their fullest potential to manage their lives; and
- **b.** Provide respite to households in which the burden of care for aged persons' rests with household members who find it difficult to provide the level of support needed to prevent institutional placement.

14. Volunteer Records

The Contractor shall ensure the collection of current and accurate volunteer data for each volunteer. The Contractor shall ensure that volunteer records are stored in locked files. Personal information contained on the enrollment forms, such as home address, shall not be disclosed, except with the express prior written permission of the volunteer. Records are also subject to state law or local ordinance governing access to records. The RELIEF Volunteer File Checklist (Attachment XVII) shall be used to ensure each file contains the following signed and/or completed information:

- a. Position Description;
- **b.** Volunteer Application;
- c. Reference Check Documentation;
- **d.** Documentation verifying successful completion of Level II background screening;
- e. Confidentiality Statement;
- **f.** Statement of Understanding (allowable and prohibited activities);
- g. Respite Assignment Sheets; and
- **h.** RELIEF Program Time and Travel Log.

15. Volunteer Recognition

The Contractor shall ensure that on-going volunteer recognition activities are conducted and shall hold at least one recognition event during the contract term to recognize the work and accomplishments of volunteers. Volunteer recognition events may be included in orientation/training scheduling plans.

16. Task Limits

The Contractor shall not perform any tasks related to this contract other than those described in this contract without the express written consent of the Agency.

17. Programmatic Reports

The Contractor is responsible for timely responding to routine and/or special requests for information and reports required by the Agency. The Contractor must establish due dates for any subcontractors that permit the Contractor to meet the Agency's reporting requirements. Reports and information that the Contractor shall provide to the Agency include RELIEF Monthly Service Record (Attachment XV) and Client Information and Registration Tracking System (CIRTS) Reports, as described in the AGENCY Handbook.

a. RELIEF Monthly Service Record

The Contractor shall submit to the AGENCY Contract Manager a complete and accurate Monthly

Service Record (Attachment XV) and CIRTS Reports by the dates provided in the Invoice Schedule (Attachment XI). The Monthly Service Record (Attachment XV) shall be completed based on the RELIEF Program Volunteer Time and Travel Log (Attachment XIV) that has been signed and dated by both the volunteer and the volunteer's supervisor.

b. CIRTS Reports

The Contractor shall ensure all clients receiving RELIEF services are enrolled in CIRTS and monthly service units are reported in accordance with the current AGENCY Handbook.

18. Records and Documentation

The Contractor shall ensure the collection and maintenance of client and service information on a monthly basis in CIRTS or any such system designated by the Agency. Maintenance includes valid exports and backups of all data and systems according to Agency standards. The Contractor shall ensure the collection and maintenance of all program-related information and documentation on any such system designated by the Agency. Maintenance includes accurate and current data and valid exports and backups of all data and systems according to Agency standards. The Contractor agrees to make available to Agency staff, and/or any party designated by the Agency, all contract-related records and documentation.

B. Staffing Requirements

- 1. Staffing Levels The Contractor shall assign its own administrative and support staff as needed to perform the tasks, responsibilities, and duties under this contract and ensure that subcontractors dedicate adequate staff accordingly. The Contractor shall designate at least one key staff member responsible for program oversight and technical assistance to subcontractors. The Contractor shall ensure that adequate staff are available to ensure access and continuity of services. The Contractor shall provide the AGENCY Contract Manager with the name and contact information for all key staff members.
- 2. Subcontractors If this contract involves the use of a subcontractor or third party, then the Contractor shall not delay the implementation of its contract with the subcontractor. If any circumstances occur that may result in a delay for a period of sixty (60) days or more of the initiation of the subcontract or the performance of the Subcontractor, the Contractor shall notify the AGENCY Contract Manager in writing of such delay. The Contractor shall not permit a Subcontractor to perform services related to this contract without having a binding, executed Subcontractor contract in place prior to the Subcontractor's provision of services.
- **3. Monitoring the Performance of Subcontractors -** The Contractor shall monitor, at least once per year, all subcontractors paid from funds provided under this contract. The Contractor shall perform ongoing fiscal, administrative, and programmatic monitoring of subcontractors to ensure subcontractors' contractual compliance, fiscal accountability, programmatic performance, and compliance with applicable state and federal laws and regulations. The Contractor shall monitor to ensure that the budget is met, the scope of work is accomplished within the specified time period, and all other performance goals stated in this contract are achieved. The Contractor shall provide copies of Annual Subcontractor Monitoring Reports to the AGENCY Contract Manager.

C. Service Location and Equipment

- **1. Service Delivery Location -** The Contractor shall ensure the services listed in this contract are provided to clients in-home.
- **2. Service Times -** The Contractor shall ensure the services listed in this contract are available at appropriate times to meet client service needs, with an emphasis on evening and weekend care. The Contractor shall ensure subcontractors have a volunteer policy that defines service times for evenings and weekends.

- **3.** Changes in Location or Service Times- The Contractor shall provide the AGENCY Contract Manager with thirty
 - (30) Days' notice of any plan that temporarily or permanently changes any service delivery location or service times.
- **4. Equipment -** Contractor shall be responsible for supplying, at its own expense, all equipment necessary for its performance under this contract including, but not limited to, computers, telephones, copiers, fax machines, maintenance and office supplies.

D. Contractor Responsibilities

- 1. Contractor Unique Activities All tasks listed above in Section II.A., Service Tasks, Performance Measures, Deliverables, and Source Documentation, are solely and exclusively the responsibility of the Contractor and are tasks for which, by execution of this contract, the Contractor agrees to be held accountable.
- **2.** Coordination with Other Entities Notwithstanding that services for which the Contractor is held accountable involve coordination with other entities in performing the requirements of this contract, the failure of other entities does not alleviate the Contractor from any accountability for tasks or services that the Contractor is obligated to perform pursuant to this contract.

E. Agency Responsibilities

- 1. Agency Obligations The Agency may, within its resources, provide technical support and/or assistance to the Contractor to assist the Contractor in meeting the requirements of this contract. The Agency's support and/or assistance, or lack thereof, shall not relieve the Contractor from full performance of contract requirements.
- **2. Agency Determinations -** The Agency reserves the exclusive right to make certain determinations in the tasks and approaches to tasks performed by the Contractor. The absence of the Agency setting forth a specific reservation of rights does not mean that all other areas of this contract are subject to mutual agreement.
- **F.** Monitoring and Evaluation Methodology The Agency shall review and evaluate the performance of the Contractor under the terms of this contract. Monitoring shall be conducted through direct contact with the Contractor via telephone, in writing, or on-site visit. The primary, secondary or signatory of the contract must be present for any on-site programmatic monitoring visit. The Agency reserves the right to conduct an unannounced on-site visit by persons duly authorized by the Agency. The Agency's determination of acceptable performance shall be final. The Contractor agrees to cooperate with the Agency in monitoring the progress of completion of the service tasks and deliverables. The Agency may use, but is not limited to, one or more of the following methods for monitoring:
 - 1. Desk reviews and analytical reviews;
 - 2. Scheduled, unscheduled, and follow-up on-site visits;
 - **3.** Client visits:
 - **4.** Review of independent auditor's reports;
 - **5.** Review of third-party documents and/or evaluations;
 - **6.** Review of progress reports;
 - 7. Review of client satisfaction surveys;
 - **8.** Agreed-upon procedures review by an external auditor or consultant;
 - **9.** Limited-scope reviews; and/or
 - **10.** Other procedures as deemed necessary by the Agency.

III. METHOD OF PAYMENT

A. Payment Method Used – The method of payment is a combination of Fixed Price/Unit Cost and Cost Reimbursement. The total contract amount may not exceed the amount found on page one of this contract. The Agency will pay the Contractor upon satisfactory completion of the Tasks/Deliverables, as specified herein and in accordance with the terms and conditions of this contract.

B. Service Unit

- 1. Cost reimbursement Payment may be authorized only for allowable expenditures which are in accordance with the services specified herein. The Contractor must meet the minimum level of performance stated in the contract in order to receive quarterly payments.
- 2. Fixed Price/Unit Cost The service unit for this contract shall be measured as one (1) hour of respite are to an eligible client or one (1) hour of pre-service or in-service training.
- **C. Method of Invoice Payment -** Payment shall be made upon Contractor's presentation of an invoice subsequent to acceptance and approval by the Agency of the deliverables shown on the invoice.
 - 1. In order to receive payment, the Contractor shall comply with the following invoice, reporting, documentation, and submission requirements:
 - **a.** Each invoice shall include a Remittance Address;
 - **b.** Fixed Price/Unit Cost Request payment monthly for the units of services completed during the reporting period. Documentation of service delivery must include the RELIEF Budget Summary Record, CIRTS Report, and volunteer time sheets. Payment shall be made for services at a rate of \$9.00 per unit. All units of service, including training hours, shall be reported on the RELIEF Budget Summary (Attachment X), included in CIRTS, and submitted with the monthly invoice along with supporting documentation. Invoices must include volunteer time sheets and training documentation. Fixed unit cost payment requests must show units of service and applicable unit costs with extensions that equal the total invoice amount; and
 - c. The Contractor shall submit the final invoice to the Agency no later than August 1, 2021.
 - **d.** Payments shall be made pursuant to the Schedule of Deliverables as follows:

D. Corrective Action Plan (CAP)

- 1. Contractor shall ensure one hundred percent (100%) of the deliverables identified in Section II. of this contract are performed pursuant to contract requirements.
- 2. If at any time the Contractor is notified by the Agency Contract Manager that it has failed to correctly, completely, and/or adequately perform contract deliverables identified in Section II. of this contract, the Contractor will have ten (10) days to submit a CAP to the Agency Contract Manager that addresses the deficiencies and states how the deficiencies will be remedied within the time approved by the Agency Contract Manager. The Agency shall assess a Financial Consequence for Non-Compliance on the Contractor as referenced in Section III.E. of this contract for each deficiency identified in the CAP which is not corrected pursuant to the CAP. The Agency will also assess a Financial Consequence for

failure to timely submit a CAP.

- **3.** If the Contractor fails to correct an identified deficiency within the approved time specified in the CAP, the Agency shall deduct the percentage established in Section III.E. of this contract from the payment for the invoice of the following month.
- **4.** If Contractor fails to timely submit a CAP, the Agency shall deduct the percentage established in Section
 - III.E. of this contract for each day the CAP is overdue. The deduction will be made from the payment for the invoice of the following month.
- **E. Financial Consequences** –The Agency will withhold or reduce payment if the Contractor fails to submit any of the following Supporting/Source Documentation in the time and manner specified or to the satisfaction of the Agency according to the requirements stated herein. The following financial consequences will be imposed if the deliverables stated do not meet in part or in whole the performance criteria as outlined in this contract.

Deliverables #1 - 12 - Failure to perform the service tasks in the time and manner specified will result in a reduction of five percent (5%) of the total deliverable amount per business day that the required service tasks and documentation are not submitted. Documentation that must be submitted to the Agency for each deliverable to evidence completion of Deliverables #1 - 12 includes:

- **a.** Complete and accurate Monthly Service Record;
- **b.** Complete and accurate CIRTS report on units of service;
- c. Approved monthly volunteer time sheets; and
- **d.** Complete Cost Reimbursement Summary form.
- **F. Minimum Performance Level** In order for the minimum performance level to be met, all of the following must occur:
 - **a.** Contractor must perform the required service tasks and deliverables in the time and manner specified in this contract;
 - **b.** Contractor must submit all required documentation and supporting documentation as stated in the Schedule of Deliverables;
 - c. Required and supporting documentation must be submitted using the required templates; and
 - **d.** The content of the required and supporting documentation must align with the Service Task requirements for Deliverables #1-12.

IV. SPECIAL PROVISIONS

A. Contractor's Financial Obligations

1. Use of Service Dollars and Management of the Assessed Priority Consumer List

The Contractor shall spend all funds provided by the Agency for the purpose specified in this contract. For each program managed by the Contractor, the Contractor must manage the service dollars in such a manner so as to avoid having a wait list and a surplus of funds at the end of the contract period. If the Agency determines that the Contractor is not spending service funds accordingly, the Agency may transfer funds to other AAAs during the contract period and/or adjust subsequent funding allocations accordingly, as allowable under state and federal law.

B. Contract Modifications - The Agency Contract Manager has the authority to modify and/or extend deliverable deadlines. All deliverable extension requests must be made, in writing prior to the required deadline, to the Agency Contract Manager. All approvals for deliverable extensions must be

communicated, in writing, by the Agency Contract Manager to the Contractor and are subject to the sole discretion of the Agency Contract Manager. The requests and the approval must occur prior to the established deadline. An e-mail writing (request and response) is considered acceptable.

- **C. Volunteers** The Contractor shall ensure the use of trained volunteers in providing direct services delivered to older individuals and individuals with disabilities needing such services. If possible, the Contractor shall work in coordination with organizations that have experience in providing training, placement, and stipends for volunteers or participants (such as organizations carrying out federal service programs administered by the Corporation for National and Community Service).
- **D.** General Procurement Standards The Contractor shall not order equipment or supplies, provide services, or perform any other action related to this contract until notified that this contract has been executed by the Agency. These same actions shall not take place after this contract has expired.

E. Remedies for Nonconforming Services

- 1. The Contractor shall ensure that all goods and/or services provided under this contract are delivered timely, completely, and commensurate with required standards of quality. Such goods and/or services will only be delivered to eligible program participants.
- 2. If the Contractor fails to meet the prescribed quality standards for services, such services will not be reimbursed under this contract. In addition, any nonconforming goods (including home delivered meals) and/or services not meeting such standards will not be reimbursed under this contract. The Contractor's signature on the Request for Payment Form certifies maintenance of supporting documentation and acknowledgement that the Contractor shall solely bear the costs associated with preparing or providing nonconforming goods and/or services. The Agency requires immediate notice of any significant and/or systemic infractions that compromise the quality, security, or continuity of services to clients.

F. Incident Reporting

The Contractor shall notify the Agency immediately, but no later than forty-eight (48) hours from the Contractors awareness or discovery, of changes that may materially affect the Contractor or any subcontractor's ability to perform the services required to be performed under this contract and in authorizing proviso. Such notice shall be made orally to the AGENCY Contract Manager (by telephone) with an email to immediately follow, including the Contractor's plan for provision of services authorized in proviso.

G. Investigation of Criminal Allegations - Any report that implies criminal intent on the part of the Contractor or any subcontractors and referred to a governmental or investigatory agency must be sent to the Agency. If the Contractor has reason to believe that the allegations will be referred to the State Attorney, a law enforcement agency, the United States Attorney's office, or other governmental agency, the Contractor shall notify the Inspector General at the Agency immediately. A copy of all documents, reports, notes, or other written material concerning the investigation, whether in the possession of the Contractor or Subcontractors, must be sent to the Agency's Inspector General with a summary of the investigation and allegations.

H. Enforcement

- 1. In accordance with Section 430.04, F.S., the Agency shall rescind designation of an AAA or take intermediate measures against the Contractor, including corrective action, unannounced special monitoring, temporary assumption of operation of one or more programs by the Agency, placing Contractor on probationary status, imposing a moratorium on Contractor action, imposing financial penalties for nonperformance, or other administrative action pursuant to Chapter 120, F.S., if the Agency finds that any of the following have occurred:
 - a. An intentional or negligent act of the Contractor has materially affected the health, welfare, or

- safety of clients or substantially and negatively affected the operation of an aging services program;
- **b.** The Contractor lacks financial stability sufficient to meet contractual obligations or contractual funds have been misappropriated;
- c. The Contractor has committed multiple or repeated violations of legal and regulatory requirements or Agency standards;
- **d.** The Contractor has failed to continue the provision or expansion of services after the declaration of a state of emergency;
- **e.** The Contractor has exceeded its authority or otherwise failed to adhere to the terms of this contract with the Agency, or has exceeded its authority or otherwise failed to adhere to provisions specifically provided by statute or rule adopted by the Agency;
- **f.** The Contractor has failed to properly determine client eligibility as defined by the Agency or efficiently manage program budgets; or
- **g.** The Contractor has failed to implement and maintain a Agency-approved client grievance resolution procedure.
- 2. In making any determination under this provision, the Agency may rely upon findings of another state or federal agency or other regulatory body. Any claims for damages for breach of contract are exempt from administrative proceedings and shall be brought before the appropriate entity in the venue of Leon County, Florida. In the event that the Agency initiates action to rescind an AAA designation, the Agency shall follow the procedures set forth in 42 U.S.C. § 3025(b).


